Whereas Neighborhood councils are the boots on the ground for LA city government and are often the first place stakeholders turn when having issues.

Whereas our service to the City and our communities is on a volunteer basis, but we are elected to our positions representing our communities.

Whereas the neighborhood council system was established to give Angelenos a clearer path to have their voices heard in City Government.

Whereas the Neighborhood Councils are an advisory body to the Mayor and City Council.

Whereas the seven Commissioners on the Board of Neighborhood Commissioners represent the seven diverse geographic areas of the Neighborhood Council System.

Whereas the Board of Neighborhood Commissioners makes and oversees policies on behalf of the Neighborhood Council System.

Now, therefore, let it be resolved that the Reseda Neighborhood Council request that all appointments to the Board of Neighborhood Commissioners have a formal feedback process wherein the Neighborhood Councils can provide input on who represents them and their stakeholders, with special consideration given to the feedback from the Neighborhood Councils and Alliances from the appointee's region. Furthermore, we also formally request that the current nominee be withdrawn until such time that Neighborhood Councils have ample opportunity to provide this feedback.

This item passed in a Brown Act noticed meeting on February 21, 2023 with a vote 8 yes and 1 ineligible.
