Elizabeth Zamora is the Chief Executive Officer of Bright Prospect, a college access and completion program working with high school students and college students nationwide. Bright Prospect supports low-income, first-generation students to get to and through college. Serving thousands of high school and college students, every Bright Prospect student receives college readiness programming, one-on-one coaching, application assistance, financial assistance and ongoing mentoring from peers and professionals from ninth grade to college graduation.

Zamora previously worked in healthcare, as Executive Director of Women's and Children's Health Development at Cedars-Sinai Medical Center and as Executive Director of Development and Alumni Relations at the UCLA School of Nursing.

An active community leader, she is presently a member of the West Adams Terrace Historic Preservation Overlay Zone within the Los Angeles City Planning Office of Historic Resources and previously served as the Chair of the Planning and Land Use Committee for the Del Rey Neighborhood Council.

Zamora is presently the Chair of the Board of the Play Equity Fund established by the LA84 Foundation, and the Chair of the Board of Western University of Health Sciences. She is presently a Board Trustee at the Westside Neighborhood School and a past board member of Bright Star Schools. In addition, she is the Co-Chair of the Los Angeles Area Chamber of Commerce Education and Workforce Development Policy Council.

You must schedule the appointment **within one week** of receiving this letter.

Should this apply to your Commission, you will be receiving a packet from the City Ethics Commission containing information about the City's conflict of interest laws, and a copy of the State Form 700/Statement of Economic Interests. You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission at 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012.
