

TRANSPORTATION COMMITTEE REPORT relative to establishing oversize vehicle parking restrictions along certain street segments of Lurline Avenue, Hayvenhurst Avenue, Burton Street, Rinaldi Street, Stagg Street, and Devonshire Street, in Council District 12 (CD 12).

Recommendation for Council action, pursuant to Resolution (Lee – Rodriguez):

RESOLVE to:

1. PROHIBIT, pursuant to Los Angeles Municipal Code Section 80.69.4, the parking of vehicles that are in excess of 22 feet in length or over 84 inches in height, during the hours of 2:00 a.m. to 6:00 a.m., along the following street segments:
 - a. West side of Lurline Avenue from Superior Street to Plummer Street
 - b. West side of Hayvenhurst Avenue from Rayen Street to Nordhoff Street
 - c. Both sides of Burton Street between Andasol Avenue and Louise Avenue
 - d. South side of Rinaldi Street from Haskell Avenue to 405 Freeway
 - e. Both sides of Stagg Street from Louise Avenue to Del Norte Street
 - f. Both sides of Devonshire Street from Topanga Canyon to Farralone Avenue
2. DIRECT the Los Angeles Department of Transportation (LADOT), upon the adoption of this Resolution, to post signs giving notice of a "tow away, no parking" restriction for oversized vehicles, with the specific hours detailed, at the above locations.
3. AUTHORIZE the LADOT to make technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

On September 18, 2024, your Transportation Committee considered a Resolution (Lee – Blumenfield) relative to prohibiting the parking of oversize vehicles between 2:00 a.m. and 6:00 am on certain street segments in CD 12, as detailed in the Resolution and in Recommendation No. 1 above. According to the Resolution, areas in the North San

Fernando Valley are experiencing public safety issues associated with large vehicles that are parked overnight and block travel lanes, thereby creating hazardous conditions. Pursuant to LAMC Section 80.69.4, it is proposed that the parking of vehicles that are in excess of 22 feet in length or over 84 inches in height, during the hours of 2:00 a.m. to 6:00 a.m., be prohibited along the street segments as detailed in Recommendation No. 1. After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of the Resolution. This matter is now submitted to Council for its consideration.
