The CIS process was enable by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or rResolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website.Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Councils rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

Motion: HHWNC opposes CF-Council File # 24-0867 - NEIGHBORHOOD COUNCIL BYLAWS (Rodriguez – Hernandez) to amend NC By Laws to Enforce Term Limits on Neighborhood Councils and also Require Youth Chair seat on NC Boards. Motion passed Unanimously 18 yay – 0 nay Board comments included: Re: Term Limits: The difficulty drawing candidates

to NC boards who have the time and commitment to fulfill these requirements is impossible to over emphasize. Keeping trained board members who have learned the ropes of serving and the numerous citywide contacts as well as developed relationships with community members, council district members and staff, DONE reps in all areas is essential to running effective NCs is difficult. These board members keep the meetings civilized and active and show up – allowing for meetings to continue with quorums being met. Re: Youth Chair: HHWNC has had a youth chair representative in the past. The 16-year-old had problems with the length of the meetings. His mother had to accompany him as chaperone. She was concerned over the area's crime risk, and the hours. The youth was missing family dinner time, sports activities and time to complete homework and the opportunity to interact with his friends, family and schoolmates. The young man resigned. HHWNC has a COMMUNITY-YOUTH Chair position which works with our two elementary schools as well as NPG opportunities to help our youth. Also in many other ways. All our seats are open to 18 and above now for election. We believe that is the minimum age that should be required to fill a board seat realistically and fairly for our dedicated board.
